

Minutes of Committee Meeting held on 3 November 1994 at the Pavilion

Present: E. Owen, D. Clarke, I. Dwerryhouse, L. Kennedy, K. Peers, H. Ruberry, E. Woodward, G. Dart. The Chairman opened the meeting by welcoming the new members.

Apologies: Nil.

Minutes of the last meeting were approved and signed.

Matters arising:

- a) S.W. Federation A.G.M. - it was reported that Sidmouth would be represented by 2 voting members, the Chairman & the Secretary, and 2 members of the Section, E. Woodward & P. Dart as observers. Details of the AGM proposals were discussed and authority given to vote as was considered appropriate at the meeting.
- b) The dates of the 1995 Short Croquet Tournament were agreed as 18th & 19th May. Members agreed that there should be the usual advert, in SWAN but that details should also be given individually to certain clubs.
- c) K. Peers told the meeting that members at the AGM had voted very positively in favour of the Belmont as venue for the Spring Luncheon. She was authorised to proceed with arrangements, the preferred date being Friday 24th March.
- d) It was noted that a winter lawn was in operation from 1 November.

continuing help and encouragement were of vital importance and the matter should be under constant review.

Minutes of the last meeting were approved and signed.

Matters arising: Nil.

Correspondence:

- 1) The Secretary reported receipt of a letter concerning the possible formation of a National Croquet League. No enthusiasm was shown for the idea and it was agreed that no action be taken.
- 2) The Secretary said that to date 7 letters of resignation had been received. The membership therefore stood at 106, inclusive of 5 Country members and 1 Student.
- 3) The amounts of Registration fees for 1995 were given to the meeting: a) to the S.W. Federation £36 plus £5 for each League Section entry: i.e. 3 x £5 for Federation, Intermediate, and 'B' League entries. This amount (£51) would be paid in January.
b) to the C.A. £495, an amount worked out on a capitation fee of £5 per member. By arrangement with the Club Treasurer this amount (due by 1 May) would be paid in April.

Some discussion was generated by the realisation that as from last year no relief was being given to the Club in acknowledgement of individual subscriptions paid direct to the C.A. by Associate members, and the Secretary was asked to make comment to the C.A. on this apparent double levy, the letter to be sent through the S.W. Federation representative on the C.A. Council.

Iris Dwerryhouse reported that some dates for League matches were already arranged and that a full list would be available in the New Year. She said that Sidmouth had been asked to host the Intermediate Finals at the end of September. Dates of 23rd or 24th had been suggested but neither date as yet confirmed.

David Clarke gave income/expenditure figures for weekly table tennis and 2 Whist afternoons since the beginning of November, reporting that attendance had been very good. He said that £97.90 had gone to the Club Treasurer as a donation from the Section.

He sought guidance on the proposed Visitors fee for 1995, it was agreed to keep it at the current rate of £2 for adults, with £1 charge for students and under 18s.

L. Kennedy reported that he had taken an inventory of all equipment held. He also gave a brief account of the Management meeting attended by him as Croquet representative.

K. Peers confirmed the date of the Annual Lunch as 24 March and her suggested charge of £10.25 was accepted by the meeting.

The Secretary gave a report on the S.W. Federation A.G.M. of 6 November. Items of interest were that the Regional Golf Croquet Finals would be run in 2 handicap sections, + 14 & - 14; and that the Regional Coaching Officer was now Ray Ransome of the Bristol Club, David Purdon having retired from the post. There was to be a Grade 1 Coaching course at Bristol in April 1995.

Any Other Business:

Potential new members: The Secretary said that the date of 11 March had been agreed with the Training Officer, E. Kitchener, for the introductory meeting, and a new and improved edition of Know the Game had been approved for issue to trainees. After brief discussion members agreed that the training course fee for 1995 should be (inclusive of the training book) £14.

The proposed date for a lunchtime meeting to welcome new members at the successful conclusion of their initial training was given and agreed as Saturday 29 April from 12 noon.

The Chairman informed the meeting of the existence of a silver cup, given to the Section in 1923. She sought members' views on suitable use for it, offering as one proposal the introduction of a new internal tournament to be played in the evenings only. An alternative idea put forward by Iris Dwerryhouse was to use the cup as a trophy for the September Open - at present only cash prizes were given. It was agreed that no immediate decision was needed, but that members could be considering possibilities for discussion at a later date.

Iris Dwerryhouse expressed concern at the lack of use of the lawns in the evenings, and wondered whether the Friday Golf Croquet slot could not revert to its former 6 p.m. start time. A Club evening specifically aimed at the newer members was also for consideration. Elaine Woodward said that the lawns were more available in the evenings for new members to practise, and they could well be encouraged to book time then.

The Chairman told members that she was interested in encouraging foreign players to come to Sidmouth to play in Open Tournaments. She referred to 1 Italian & 2 French Clubs as well as the Jersey Club and volunteered her services as secretary and interpreter in the issuing of invitations. Members approved the suggestion.

Open Tournaments: Iris Dwerryhouse told the meeting that home Club entries would have to be restricted in some way, with an initial figure of say 10 max. out of the intended 24 players total. She asked members to give thought to ways of resolving this problem.

Training: The Secretary reported that 2 dates had been agreed with the Training Officer for pre-season refreshers; Saturday 25 February & Saturday 18 March, both meetings from 10 a.m. to 12 noon.

Short Croquet: Members agreed that the customary Club day (no fee, no prize) should take place on Saturday 20 May following the S.W. Federation Open Tournament on 18 & 19 May.

Golf Croquet: The date of the Regional qualifying round was given as 1 July: entry fee £1 per event.

Committee meeting dates through the season were given as follows:-11 April, 2 May, 6 June, 11 July, 8 August, 5 September.

Minutes of the last meeting were approved and signed. Matters arising:

- a) H. Ruberry reported that soundings among regular Friday players of Golf Croquet had suggested a strong preference for retention of the 4 p.m. start. After some discussion it was agreed to have, as last year, 3 lawns available at 4 p.m. on Fridays for organised Golf Croquet, with 1 lawn booked for the 6 p.m. slot to accommodate those who might wish to stay on or arrive later.
- b) The Chairman asked members for their considered views on use of the 'spare' silver cup. Opinions voiced were that to fit another internal tournament into the already crowded schedule would be difficult, and the better option would be therefore to use the cup as trophy for the September Open weekend. I. Dwerryhouse pointed out that adjustments to the proposed format for the Tournament would be necessary to achieve a one cup, one winner result; and it was agreed that the cup would probably be used in September, subject to some further thought.

Correspondence: Nil.

Reports:

D. Clarke reported through the Chairman that a further £30 had been donated to the Club funds as profit from table tennis and one Whist Drive in the past month.

E. Woodward had nothing to report but asked that the Committee consider dates for some of the internal tournaments. Decisions were made as follows:

H. Ruberry asked that the internal Golf Croquet Tournament dates should be considered. These were agreed as 6 & 7 September. I. Dwerryhouse said that she had put a report in last week's 'Herald' which included an invitation to get in touch with the Croquet Secretary if interested in learning how to play.

L. Kennedy reported that he would be attending a Main Club Committee meeting on 12 January, any information relevant Section being reported back to this Committee at the February meeting.

H. Ruberry asked that internal Golf Croquet Tournament dates should be considered. These were agreed as 6 & 7 September.

I. Dwerryhouse said she had put a report in last week's 'Herald' which included an invitation to get in touch with the Croquet Secretary if interested in learning how to play.

She reported that the agreed date for the S. W. Federation Intermediate Finals to be played at Sidmouth was Sunday 1 October.

K. Peers showed members the Lunch tickets, produced courtesy Brian Smith, and her suggestions for seating were agreed. An amended price of £10.50 was noted. The proposal that members who had just resigned be invited to attend the Lunch was accepted.

Any Other Business:

I. Dwerryhouse asked that in addition to the Club afternoons on Mondays an evening be set aside more particularly for the benefit of newer members. Wednesday seemed to be the preferred evening, and it was agreed therefore that Club afternoons would start on Monday 1 May (1 p.m. - 4 p.m.), and that on each Wednesday from 3 May there would be a Club evening starting at 6 p.m.

Members agreed that Lawn 2 should be marked out at the start of the season as 2 half-sized lawns, and would remain so until the end of May. L. Kennedy was asked to arrange this with the Groundsman. He was asked also to confirm the Lawns Open date as Saturday 1 April,

The need for some pre-season maintenance was recognised and L. Kennedy asked for help with names of willing workers.

I. Dwerryhouse pointed out that since so many sets of balls are now available in the Croquet Pavilion there was no longer need for a Practice Balls Locker in the Mallet Room. She suggested that this locker should be used to accommodate some of the balls in general use, thus avoiding over-crowding.

She asked also that the colour-coding on the ball cradles should be checked and renewed.

The Secretary expressed some anxiety that the 'Winter Lawn' might prove too popular should the weather in March be kind and suggested that a time limitation on games might be desirable, to give fair opportunity to all for pre-season practice. She was asked to produce polite notice to this effect.

The date for the Section AGM was agreed as Thursday 26 October at 2 p.m.

Minutes of the last meeting were approved and signed.

Matters arising:

- a) The Secretary queried whether Short Croquet markings for Lawn 2 from the start of the season might be helpful to the Groundsman. It was agreed that for training purposes in April 2 half-sized lawns were of more use, and the decision minuted in January should stand.
- b) The Chairman initiated further discussion on use of the spare silver cup, suggesting that if it were not to be used for the September Open then an evening tournament in June could be a viable alternative. The posting in the Mallet Room of a notice inviting entries so as to gauge possible response was proposed, and after some discussion the matter was left on the table for consideration at the next meeting.

Correspondence:

- a) The Secretary reported receipt of a reply to her letter to the Chairman of Council commenting on the Club Registration fee, and read the relevant paragraphs to the meeting. She asked members to note the promise that 'the rate would not rise by more than the rate of inflation'.
- b) The Chairman said that in response to her invitations to foreign Clubs she had received a reply from Le Douet club near Bayeux, who would not this year be coming to Sidmouth but who would be pleased to welcome visitors at any time.

Reports

K. Peers reported that sales of tickets for the Lunch were going well.

L. Kennedy said that the work of painting and repairs was in hand J the Mallet Room had been painted, and repair needed to the Robert Case corner would be dealt with. In the Croquet pavilion the upright in the S.E. corner was rotten, and he proposed to seek authority from the Main Club Committee for its professional repair. Members agreed his proposal.

He reported on the Main Club Committee's recent meeting where the issues of a new security system and a new timed watering system were discussed, and told members that use by players and spectators of the space beyond the N.E. corner of Lawn 1 had been agreed with the Sidmouth Club, the Croquet Section to be responsible for its continuing tidy appearance.

He said that he would be assessing the quantity of new balls needing to be purchased this year, and I. Dwerryhouse's request for pegging down markers as well as replacement clips was noted.

D. Clarke reported that a further £40 had been donated to Club funds I.

Dwerryhouse reported that all the League matches had now been arranged and a full list would be put on the Notice Board. Additions to the list given in the January minutes were

She gave details of entries so far received or expected for the June & September Open and the Short Croquet Tournaments, and said that more than £300 had already been passed to the Club Treasurer.

Any Other Business:

Arrangements for the 'potential players' meeting on 11 March were discussed, the Secretary reporting that the probable number was 14. I. Dwerryhouse said that in addition to the publicity posters in the Mallet Room and at the Library, there was now one in the Club Notice Board outside Lawn 2.

Dates for the Club afternoons set aside for 2 practice sessions for Two Ball and 2 for the Shot Game were agreed;

and a roster of Committee members to organise the Club afternoons through the season was noted.

There was discussion about the format of the new Club evenings, but no positive decision was reached.

The Chairman asked members to consider the advisability of changing the name of the TWO Ball game to ONE Ball, since this now seemed to be the more widely used title in the Fixtures Book and the Croquet magazine.

Minutes of Committee Meeting held on 14 March 1995 in the Pavilion

Present: E. Owen, D. Clarke, I. Dwerryhouse, L. Kennedy, K. Peers, H. Ruberry

Apologies: Nil

Minutes of the last meeting were approved and signed.

Matters arising:

- a) The Chairman said that it had been found impracticable to use the silver cup for the September Open, and that general opinion seemed to be towards holding it in reserve for the time being. A motion to this effect was proposed by I. Dwerryhouse and seconded by K. Peers, other members save one being in agreement.
- b) The Committee agreed the Chairman's proposal that an offer to arrange an evening tournament on 4 Thursdays in June, full bisque to a base of 6, should be put to members of the Section. The Chairman volunteered her services as Manager if sufficient interest were shown - a 12 entrants minimum was suggested.
- c) Formal acceptance of the ONE BALL title was made, H. Ruberry proposing, E. Woodward seconding, all members concurring.

Correspondence:

The Secretary reported that she had been advised by the C.A. that National Croquet Day would be on 3 June. After consultation with the Chairman she had replied wishing the C.A. well in their special day of effort but saying that the Sidmouth recruiting publicity had already been done.

Reports:

L. Kennedy reported from the last Main Committee meeting that the public pathway around two sides of Lawn 1 was to be resurfaced, and the gate rehung, all this at Club expense helped by a contribution from the Local Authority. The meeting expressed pleasure and the hope that thereafter something could be done about the flower boxes.

Comment was made on the railings, apparently redundant, in the Sidmouth Club corner of Lawn 1. L. Kennedy offered to mention it, unofficially, to the Club Chairman.

In his capacity as Grounds & Maintenance member L. Kennedy reported that all necessary renovation was continuing, and that the Robert Case corner had been repaired. He explained in detail the current problem of a recurring fungus on Lawn 1 and emphasized the fact that the recommended course of treatment of RIMIDIN, though expensive, was essential to control the fungus. He expressed the wish that it should be minuted that all treatment of the lawn at the present time was essential and was being done.

I. Dwerryhouse wondered whether it would not be advisable to delay the opening of Lawn 1. L. Kennedy was asked to seek the Groundsman's advice on this proposal, and all members agreed that he should be assured of the Committee's backing in any needful decisions throughout the season about lawn conditions.

E. Woodward reported that the Internal Tournaments form had been completed, and the Committee's views on the 'Ladder' were sought. After some discussion it was agreed that the names of players, 14 handicap and over should be put up, the

suggestion being made that a broader base, going to only halfway up the scale, might give more encouragement to proceed.

The format for the Finals of the Belmont Cup & the Fermor Bowl was also discussed. It was agreed that the Bray system should be used throughout these tournaments, including the Finals, the only variation being that for all the Finals on 2 & 4 September, games should be without a time limit. E. Woodward noted that these decisions should be shown on the tournament from the start of the tournaments.

There was some discussion about limitations on handicap levels for entry to certain tournaments, but it was agreed to accept all entries as they came, with friendly advice available. I. Dwerryhouse suggested that any player who had reached a handicap of 20 should not, whatever the result of a match, revert to a handicap higher than 20. The meeting approved this proposal, but agreed that the matter should be discussed by the Handicap Committee.

The Cashier reported that £164 had been passed to the Club Treasurer; £74 being a donation as profit from Whist and Table Tennis; £94 being potential members' training fees. Current balance held £3.28.

I. Dwerryhouse said that all places for the June & the September Open Tournaments had been taken; and to date she had 22 entries for the Short Croquet Tournament in May. An amount of £526.50 in fees had been paid to the Treasurer.

She informed members of an invitation to a Parkstone Tournament 22-24 May.

The Social member reported that all tickets for the Annual Lunch had been sold, and a seating plan would be available at the hotel on the day.

The Secretary reported a successful 'potentials' meeting on 11 March, as a result of which 11 people would be starting training on Monday 3 April.

Any Other Business:

It was agreed that all new members would be invited to attend an informal meeting at 11.30 a.m. on Saturday 29 April (immediately preceding the lunch-time 'get together') to be briefed on Club procedures and to have the opportunity to ask questions. At this meeting the Chairman hoped to introduce and arrange the agreed 'minder' system.

The attention of members was drawn to the private notice in the Mallet Room about a forthcoming wedding.

Minutes of the last meeting were approved and signed.

Matters arising:

The Chairman said that so far there had been little response to the proposed June event, and suggested that a closing date for entries of 1 May be set. Members were in agreement.

Correspondence:

The Secretary reported that the Sports Co-ordinator for the S.W. Region W.I. had contacted her on the recommendation of the S.W. Federation Secretary, making tentative enquiry about the possibility of using the Sidmouth lawns for a day of Golf Croquet by some 24 W.I. members during September. She sought the view of the Committee on this issue should a more positive approach be made, and after some discussion it was agreed NOT to accept the proposal.

Application to join the Section had been made by one John Brightmore, whom E. Kitchener was happy to sponsor. The Committee agreed to accept his application.

Reports:

He reported that the purchase of new balls and markers was in hand, as was the repair to the Croquet Pavilion. He had as yet no firm date for the resurfacing of the pathway.

Comment was made on 2 instances of bags of kitchen waste found to be deposited in the Sidmouth Club corner of Lawn 1. L. Kennedy noted the complaint.

The Cashier reported that £35 had been sent to the Club Treasurer and that a balance of £4.70 was held.

H. Ruberry asked that nearer the time for the Golf Croquet Tournament a list should be put on the Notice Board both to remind those who had already entered and to seek extra entries. This request was noted and approved.

K. Peers Presented to the Committee proposed menus for lunches for the June Tournament, offering her services should no Club catering facilities be available. L. Kennedy was asked to bring the matter to the attention of the Club Catering Officer at the next Main Club Committee meeting and to seek guidance, or authority for the Section to act alone. It was accepted that a lot of helpers would be needed, and the suggestion that a paid helper should be sought to do the washing-up was met with approval.

The Chairman thanked the Social member for her work in connection with the Annual Lunch, which was appreciated by all those who attended; and a vote of thanks, proposed by D. Clarke, seconded by H. Ruberry, was carried nem. con.

I. Dwerryhouse reported that £586 had gone to the Club Treasurer for Open Tournament fees (inclusive of 27 x £5.50 for Short Croquet). She expressed her hope that a full house of 32 players would be achieved for the Short Croquet Tournament, and gave details to L. Kennedy of equipment needed. Matters arising:

- a) Only 2 names having been received for the proposed June event, it was accepted that no further action be taken.
- b) The Secretary reported that following an exchange of letters between L. Kennedy and the Club Secretary, it had been agreed that an outside caterer be used to provide lunch-time meals for the duration of the June Tournament. All arrangements were to be the responsibility of the Bar Steward, Chris Bridle, and it was understood that he had booked a Budleigh Salterton firm who had experience in dealing with the Budleigh tournaments.

Teas, except for Thursday June when Cricket teas would be available, would be for the Section to arrange.

Correspondence:

- a) Receipt of a brochure advertising an Open Tournament in Jersey was reported to members - a copy had been put on the Notice board.
- b) One more resignation was reported. Section membership now stood at 108, inclusive of 10 new members.

Reports:

E. Woodward reported that she would now be arranging internal tournament details. It was recommended that the 'Devonia' blocks should be on the Notice board by the weekend if possible, so that members would be encouraged to start playing matches during 'Budleigh week' when the Sidmouth lawns would be less heavily booked.

The number of players entered for the Club Short Croquet day on 20 May was reported as 19.

A total of £106.50 in Tournament fees was to be passed to the Treasurer.

D. Clarke as Cashier reported that a further £28 had been sent to the Treasurer, and that a balance of £28.20 was held.

H. Ruberry said that the annual friendly Golf Croquet matches between Sidmouth and Budleigh Salterton had been arranged for 30 June at Sidmouth, and 12 September at Budleigh. All 4 lawns would be needed from 2 p.m. - 5.30 p.m. on 30 June, and tea arrangements would be necessary.

L. Kennedy reported that at the Grounds Committee meeting the previous evening discussion of a letter from A. Dustan-Smith to R. Packe, Grounds Chairman, expressing concern at the condition of Lawn 1, brought to members' attention that the present cost of treating the fungus disease worked out at about £900 per annum. This figure was noted with some disquiet by the representatives of all 3 playing Sections.

Within the Croquet Section Committee disquiet was also expressed, and the possibility of getting independent expert advice explored, though it was recognised that ultimate responsibility lay with the Grounds Committee.

Members did regret that a Section member's concern over the condition of a croquet lawn had not initially been channelled through the Section's Committee, and the Secretary was asked to write A. Dustan-Smith on this matter.

I. Dwerryhouse reported that she had a total of 28 players for the Short Croquet Open Tournament, and proposed that the format should be a 2 blocks Swiss. Tea arrangements were in hand.

Matters arising:

- a) See L. Kennedy's report 2 May - The Chairman said that after discussion with the Secretary she had decided that the interests of the Section would not be best served by exchange of letters, and that the matter should be allowed to rest.
- b) Referring to the W.I. members' intended visit at the May Bank holiday and a reported embarrassment for 2 Section members it was agreed that the Secretary should have informal words with the EDDC on the rules and regulations of the Sidmouth Club.

Correspondence:

- a) The Secretary reported receipt of a letter from Peter Coomber giving formal notice of resignation because of an eye problem.
- b) Members were notified of receipt of a Development Newsletter from Chris Hudson, the C.A. Development Officer, and were told that this was the first of a proposed quarterly series. It was suggested that it should be put on the Notice Board for Section members' interest.

Golf Croquet Tournament, the first round of which had been arranged for 1 July, Iris Dwerryhouse reported that only 6 members had so far paid an entry fee, a number which in her view hardly justified the effort of putting on the Tournament. It was agreed that a notice should be put in the Croquet Pavilion forthwith, duplicating the notice which had been in the Mallet Room since early April, to see if there were any further response before making a decision.

She reported that an inconclusive letter had been received in reply to her letter about Handicapping, and that she proposed to write again.

The Cashier reported that £50 had gone to the Treasurer, leaving a balance of £13.50 in the account.

H. Ruberry said that the Golf Croquet home match against Budleigh (see minutes 2 May) was arranged for Friday 30 June, and asked that tea be provided for about 24. She reported that there had been an attendance of 38 at the previous week's Wednesday morning session.

E. Woodward reported that all tournaments seemed to be under way: her request for a minor adjustment of players within the published schedule was agreed. Reports:

The Secretary reported receipt of

- a) a letter from L. Sage accepting the Committee's invitation to present the prizes at the AGM; thanking the section for its help at the Garden Party; and saying that the Garden Party was to be discontinued.
- b) a thank-you letter from the CA Development Officer concerning the Club survey.
- c) a letter from the CA Office offering Inter-net facilities
- d) a letter from the SW Fed. Secretary giving details of the Federation AGM, to be held. at Tracey Park on 5 November.

Reports:

H. Ruberry reported that the Golf Croquet friendly match v Budleigh played in September at Budleigh had resulted in a win 10 - 6 for Budleigh. A few members had also visited Budleigh one Sunday by special invitation for an enjoyable afternoon's play.

She reported on a successful 2-day Club Tournament in early September and thanked I. Dwerryhouse for her expert management.

As our programme of events is already very full your Committee has decided not to proceed with the proposal put forward at the AGM that a new tournament for 'Veterans' should be introduced: neither will there be a Short Croquet Open Tournament this year.

COMMITTEE REPORT 1995

The weather in this country is always a safe opening remark, but this year, I think you will agree, it does deserve special mention. Our long spell of unbroken sunshine enabled the initial training Programme in April to be completed in record time, and the June Open Tournament ran so smoothly that there was time for an unscheduled doubles event on the fifth day. What a pity therefore that the September Open weekend, after a glorious first morning, had on the second day to be abandoned at lunch-time because the lawns were under water. That's British weather for you. We must congratulate and thank Peter Montgomery, the Club groundsman, for maintaining the lawns to such a high standard throughout the season. A number of players from other Clubs have made flattering comment on the lawns' superiority, and we are indeed grateful for his work on our behalf.

Our membership now stands at 109. As happens each year a few members reluctantly cease to play, although we are always glad when they retain Social membership as a way of keeping in touch, and are particularly pleased to welcome them at the winter whist afternoons -but their places are taken by new entrants, so that for several years now membership has remained at a healthy 100 plus.

A full programme of events has been staged through the season, starting with the Short Croquet Tournament, open to members of the S.W. Federation. In spite of extensive and individual publicity there was a poor response from other Clubs. 24 players took part, 10 being non-Sidmouth. The Dorothy Toye Cup was won by Vera Henderson, and a profit of £124 was made for Club funds.

The June Open, now in its 4th year, attracted much interest and was over-subscribed 3 months before the closing date. Local entry was restricted to 9 Sidmouth players, with 15 visitors to make up the total of 24. Although none of the 3 cups was retained in Sidmouth, we were delighted for two of our members, Val & Bob Callingham, that the Fortfield Cup was won very convincingly by their son Robert, playing in his first Open Tournament. Responsibility for the catering for lunches for the 5 days of this event was passed to a local firm of professionals, which meant that no profit accrued to the Club, but the average of 36 - 40 good quality, low-priced meals served daily over the 5 days would have been a mammoth task for the most willing of volunteers, and your Committee feels that it was the best option. Bar takings, due in part to the custom generated by the lunch trade, amounted to £312 through the tournament, and a final profit of nearly £300 went into Club funds.

For the September Open weekend our current Chairman changed her role into that of Catering Officer and produced 2 days' worth of gourmet lunches which were much appreciated, the £100 profit being an extra bonus. There was an entry of 16 players, Sidmouth numbers again being restricted, and about £200 total profit made for the Club. Handicaps at this event ranged from -1 to +18, and one of our members 'enjoyed' (if that is the right word) the sight of 17 bisques at her disposal.

3 of the 4 block winners were local players, Tony Dustan-Smith, Don Waterhouse, and Brian Smith.

There were plenty of entries for the various Club Tournaments held through the season, and you will be reminded of the results when the impressive display of trophies is distributed at the close of this meeting.

S.W. Federation results have been the usual mix of wins and losses, but all games have been enjoyable, providing the opportunity of meeting players from other clubs, either here or at their home ground. The season ended with Sidmouth hosting, on 1 October, the Final of the Intermediate League between Kington Langley and Plymouth, Plymouth being the winner after a close and exciting contest.

Seeing other clubs, meeting new people, playing unknown opponents, all these things are good for the game, and as well as taking part in inter-club matches, Sidmouth has during the year been represented at Open Tournaments very worthily and successfully by individual members playing at Parkstone and Woking as well as at Budleigh Salterton. Four members travelled all the way to Bowden in Cheshire to attend an Intermediate level weekend course, and two members did a similar exercise for higher bisquers at Bristol.

Our own training programme has, we hope, been a useful one. In February and in March we had training meetings, one a Quiz, both very well supported. The 'crash course' in April, attended by 11, resulted in 9 new members, who were encouraged to come to a weekly Club evening for newer members where coaching on game play was given. This was a new venture and your Committee hopes it was of benefit. For 2nd year players, Eric Kitchener again produced an excellent series of coaching lessons, well attended and much appreciated.

Golf Croquet enjoyed its usual popularity on Wednesday mornings and Friday afternoons; and the 2-day Club Tournament in September was a successful event under Iris Dwerryhouse's expert management. The traditional friendly games between Budleigh and Sidmouth resulted in home wins for each club, and some members went over to Budleigh in August by special invitation to have an afternoon's pleasure together.

The S.W. Federation Open Golf Croquet Tournament on 1 July attracted a good entry after a slow start and the winners were Eric Kitchener with Peggy Webber runner-up in the Singles, and Eric & Linda Kitchener the Doubles winners with Tony Dustan-Smith & Valerie Collier the runners-up. Hugh Read with David & Cecilia Clark went to Nailsea in September to represent Sidmouth in the Finals.

Social activities: During last winter members kept in touch regularly through the very popular Table Tennis sessions run weekly on Wednesday mornings; and the monthly Whist afternoons were as well attended as ever, no high standard of play being required - it's strictly for fun! The annual Lunch in March was held at the Belmont Hotel.

At the beginning of May a Saturday lunch-time get-together introduced the new members to the friendliness of the section early in the season; and in mid-September, towards the end of the season, a very successful barbecue* organised by Tony Dustan-Smith, and preceded by a Fun day run by Esme Owen, confirmed the good fellowship that exists in the Section.

In early August Hugh & Ingrid Read opened their garden and gave tea to members to celebrate their success in the Britain in Bloom competition with donations to the croquet section invited. Monies received amounting to £77, were used forthwith to purchase a quantity of new chairs for the Croquet Pavilion. Our grateful thanks to you, Hugh & Ingrid.

The Croquet Section continues to take its full share of responsibility for maintaining the financial viability of the Club. As well as the in-house profits passed to Club funds members have always been ready to support fund-raising activities, by running a Cake stall & a Plant stall at the May Coffee morning, by providing the main incentive towards the success of the Garden Party in July, by individually supporting the Friends' lunches and suppers. We can be proud of the part we play in the Club.

Your committee hopes that this has been a good year in terms of personal achievement, quiet pleasure, friendship, whatever you have desired. We thank you all for your support of our efforts, and for the willing help given by so many of you towards the administration of a very active Section.

*The barbecue raised a profit of £228 for the Club. Our thanks to you, Tony, and to all your helpers for a lovely evening.
