- 2) Affiliation Membership of C.A.

The Chairman explained the hope of the C.A. that all non-Associate members of registered clubs should in the interest of boosting membership figures become affiliates of the Association, as recommended in the May issue of 'Croquet', and referred to again in the Sept. issue. The Secretary read to members the letter from the C.A. in May notifying the Club of the Apps/Heley Award, the last paragraph of which read 'In return we would expect that you would be joining the Affiliate scheme'. The meeting agreed, after some discussion, that there was some moral pressure to join, that it would be of benefit to the C.A. to have the increased membership, that though there seemed to be no particular advantage to our club neither was there any hidden disadvantage. The Secretary read the draft of a proposed letter to all members, and it was agreed that this explanatory letter should be sent out with the Spring Programme at the end of January, and that at the same time a letter should go to the

C.A. giving the required names and addresses of Club members. Proposed by M. Dawson, Seconded by M. Hardman, carried.

3) The Chairman said that the C.A. required that a plaque be provided showing the name of one S.S. Townsend as a donor of more than £100 towards the Four Lawn Fund from which our grant had come. This matter to be dealt with at a later date.

4) The Secretary reported that attendance at the AGM had been a very satisfactory 73+, and members agreed that the format of the meeting had been acceptable. M. Stant suggested that at the presentation ceremony some clarification of what each trophy had been played for would be of interest especially to newer members. This was noted for action at the 1991 AGM.

#### Any Other Business

5) Annual Lunch - M. Stant was commissioned to make preliminary enquiries and to report back at the January meeting.

6) The Chairman told members that Associates were being asked individually for contribution to a presentation to the retiring Secretary of the of the C.A., Brian MacMillan. She said that monies were being collected to send to send-up as one cheque, and asked that the club should make the amount up to £20 out of Club Funds should this be necessary. The Committee agreed this and the Secretary was instructed to send a cheque for 320 with an appropriate letter of good wishes.

7) M. Hardman voiced her anxiety about the availability of practice areas for the 1991 season. The Chairman said that maybe Lawn 3 Th could be sub-divided for the month of April; but that no firm decision could be taken at the present time.

Minutes of last meeting: After an addition had been made to the Short Croquet information, the minutes were approved and signed.

Matters arising: Nil.

Correspondence: The secretary reported that a) the Fed. AGM minutes had been received; b) the Fed. Sub. of £18 had been paid; c) The Fed's proposed date of 7 September for the Golf Croquet Final had been accepted; d) the CA registration fee had. been increased to £1.50 per non-CA member; e) the Longman Cup fee had been increased, to £20; f) a number of books had been ordered from the CA on a sale or return basis.

Reports. 1) The Chairman gave members the latest information on the Lawn project, and said that the Groundsman was now empowered to work on the part (more than half) which had been levelled. It was agreed that the Tennis Section should be approached to request use of that area through April should the rest of the ground not yet be ready for use The -The secretary was asked to express to L. Kennedy the thanks of the Committee for the considerable amount of time and effort given by him to the project and it was agreed that . that a phone call at the present time followed by a letter of thanks at the completion of the work would be appropriate.

2) E. Golding reported that repainting of the Mallet Room was well under way.

3) M. Hardman. detailed those match dates already arranged, and reported the existence of a new club, Lym Valley, with whom a 'B' League home fixture had been agreed. The amended figure for League matches in 1991 was therefore 7 matches away and 5 home.

4) M. Stant reported that more than half the tickets for the Annual Lunch had been sold.

5) The Cashier said that the January Whist Drive had made £16, with expenses of £4.07; balance held was £44.11, and it was agreed that £20 should be passed to the Treasurer.

Training: It was reported that an initial meeting for training potential new players had been arranged for the morning of Wednesday 13 March. After some discussion it was agreed that a charge of £12 should be made for a course of 6 lessons (each 1½ hours) to include a 'Play Croquet' booklet, selling price £2.95. There would be an option of dropping out after 2 lessons, in which case there would be a refund £5.

Booking sheets: It was accepted that a slot on all lawns should be provided for practice availability from 1 p.m. to 1.30 p.m., thus making afternoon sessions slip to 1.30 - 4, and. 4 - 6.30.

Any Other Business. 1) The Chairman said. that a garden seat was to be presented to the Club in memory of Lady Fermor.

2) Members accepted with thanks E. Owen's offer to be responsible for the flower troughs again this season.

3) It was agreed to made the draw for the Manor Car Park keys at the Lunch.

Minutes of last meeting: These were approved and signed.

Matters arising: The secretary reported that a) the CA Registration fee had been amended to £1.25, and the amount therefore paid had been £88.75, based on the figure of 71 non-CA members as at the qualifying time of 30 September 1990.; b) the Tennis Section was agreeable to the request for use of their area through April, but would need the lawn on 28 April for a tournament; c) the Car Park draw had been made, and key holders were as follows: A. Ward, G. Hewitt, C. Garrick, A. Rose, D. Rawkins, G. Peachey. Reserve names were: M. Kirke, M. Smekal.

Correspondence and Secretary's Report.

- a) An unsolicited section of books had been received from the CA as well as the books ordered. Members agreed that they should be returned forthwith.
- b) Three members had in January become Associates; H. Dawson, B. Longley, A. Dustan-Smith; and a Prize application had been sent to the CA.
- c) A list of 64 names for Affiliate membership had been submitted.
- d) As at 6 March the membership was 25 Associates, 54 Affiliates, 1 member whose parent Club was Exeter, and 1 Country member. There had been 4 resignations and 1 member re-joining after a year's break.

Programme for the season. After some discussion this was agreed; copy of programme to be issued to members attached.

CA Tournament for 1992: The Chairman reminded members that the Club was committed to hosting an open Tournament as from 1992, and that details would have to be finalised in good time to meet the Fixtures Book deadline of August. Possibilities were for 1) a CA-run event, e.g. Veterans, when all entry fees would go to the CA, who would pay a hire fee to the Club for use of equipment, etc., but the Club would expect to make its money out of catering. 2) a Club-run event, either weekend or 5/6 days, where entry fees would be retained by the Club, less a 30% 1 levy to the CA. Suggested timing was for late May, early June. It was agreed full discussion would take place at the April meeting.

Reports. 1) B. Golding reported that he had attended a ground committee meeting as well as a main Club meeting; that a quote was to be made for the proposed steps between Lawns 4 & 2; and that the rolling-financial plan for the next 10 years did include the possibility of auto-watering. The support of the Section was sought for the 200 Club and for the Cambridge Draw.

It was agreed that more hoops, clips, and 2 sets of secondary colour balls should be purchased.

2) M. Hardman reported that all Federation matches were now arranged.

3) For the Cashier it was reported that the Whist Drives in February and March had made £18 each, with expenses of £5.18 and £4.79, and after sundry outlays the balance held was £51.92.

Any other Business: 1) The problem of SWAN distribution was raised, but the matter held in abeyance for the time being.

2) It was reported that a W.I. in the Swanage area was a potential customer for two 2 Sets of Walker balls – selling price £10 per set.

3) G. Dart requested that appreciation of the training meeting held on 28 February should be minuted. 25 members attended under the instruction of 5 coaches.

4) The thanks of the Committee were expressed to M. Stant for her organisation of the successful lunch held on 7 March.

Minutes of last meeting. these were approved and signed.

Matters arising. The Secretary reported that the Walker balls had been sold for £20.

Correspondence: 1) A letter had been received from the National Development Officer enclosing a £12 voucher as reward for recruiting 3 new members for the CA; a further recruitment form had been enclosed.

2) The Chairman said that at the request of the Club Chairman details of groundsman's duties and responsibilities in connection with croquet requirements had been set out. Members agreed the duties and mentioned Seat maintenance a possible inclusion for Winter jobs.

3) The secretary reported a letter from the CA regarding a) Handicapping b) National Sports Day. It was agreed that these letters should be considered fully at a later meeting.

4) The Chairman said that the CA wished to promote increased playing of the advanced game and had suggested the use of bisques. It was accepted for this year at least the Humphrey Hicks Tournament should remain a level play tournament.

5) One resignation from the Club – Ralph Foster was reported.

Reports. 1) Training. 24 potential new members attended a meeting on 13 March. 28 people had begun training, though 2 had since dropped out.

2) Domestic Tournaments. H. Dawson said the entries were slowly coming in.

3) Grounds E. Golding said that the 4th Lawn had been top-dressed and was beginning to take shape., though play would not yet be possible.

4) Fed. Matches. M. Hardman reported that Sidmouth had been given a bye for the first round of the Longman Cup (which had to be completed by 2 June) the 2nd round would be against either Plymouth or Parkstone, to be played before 7 July.

5) Golf Croquet: It was agreed that Lawn 1 should not be made available for Wednesday mornings Golf Croquet.

6) The Cashier reported a balance of £164.31, £100 of which should be passed to the Treasurer.

CA Tournament 1992. Members were recommended to consider for discussion at the May meeting the advisability of asking to have a CA-run Tournament perhaps the Peel Memorial or the Challenge and Gilbey.

Minutes of last meeting were approved and signed.

Matters arising. The secretary reported that Mr. Alan Oldham had accepted with pleasure the Section's invitation to present the prizes at the AGM.

Correspondence: Rev. Sheila Scarr's letter asking that her membership should lapse for this year only was read to the members, who agreed her request.

Reports: 1) M. Stant said that she had contacted Budleigh Salterton with regard to the annual 'friendly' Golf Croquet matches but no reply yet.

2) The Cashier reported £103.50 taken in entry fees for Club Tournaments for the 3 days of Short Croquet £17.50 profit had been made on teas: a balance of £55.74 was currently in hand, a total of £484.09 having been passed to the Club Treasurer since the start of the season.

3) M. Hardman reported a) a successful 2 days of Open short Croquet, with a profit of £57 on fees; 3 prizes of £5 each having been handed out and a £9 gratuity (50 pence each of the 18 players) given to the groundsman. There were 3 block winners; Audrey Whittaker of Bath, Kay Yeoman of Bath, Leslie Toye of Sidmouth. The Dorothy Toye Cup was won by Audrey Whittaker.

b) The 2nd round of the Longman Cup was to be played on 30 June against Plymouth, and as there was no previous record of location, it was agreed that it should be played at Sidmouth. The 3rd round would have to be played by 4 August, and would be against either Dyffrin or Bears of Rodborough.

c) Arrangements been finalised for a B League (Hi) match on 2 June, and an Intermediate (A) match on 9 June.

4) E. Golding reported that a) the cost of provision of steps between Lawns 4 & 2 had been mentioned at a recent Main Committee meeting. A discussion of detailed requirements ensued. It was proposed by H. Dawson, seconded by G. Dart, that a sub-committee of R. Callingham, H. Dawson, E. Golding should agree and perhaps cost a scheme.

b) a lawn had been marked out on part of the relevelled area, and was to be available for use on a limited basis until such time as the groundsman declared it fit for tennis use. It was agreed that 1 June, designated by the CA as National Croquet Day, was a good start day; but notice would be posted giving limitations of 2 players only per game and a Golf Croquet ban, to protect the new surface from excessive wear.

. 5) H. Dawson reported 61 entrants for Club Tournaments, a total of 212 entries for events He asked that a stencilled notice should be put on Tournament Balls locker.

Advanced play - it was suggested that later in the season a 2 day tournament might be held.

CA Tournaments members agreed with the Chairman's proposals that a bid should be made for the peels Memorial Tournaments to be played at Sidmouth in 1992, the preferred date optiob being early June, with a possible second choice of September. The secretary was instructed to write accordingly.

Any other business: a) The Secretary reported that the final tally of new members in 1991 was 23.

b) It was agreed that the former ruling of unlimited visitor play for CA members be rescinded. The ruling for all visitors was a maximum of 3 times in a season, and the continuing low green fee was for the benefit of family and house guests of members.

c) The question of payment for match teas was raised, but the issue remained unresolved.

d) For National Croquet Day it was agreed that players were to be asked to wear white.

Minutes of the last meeting were approved and signed.

Matters arising: Nil

Correspondence: 1) The secretary read to members a letter from Mr Alan Oldham giving information about Mr S.S. Townsend whose financial help towards the 4th Lawn has to be recorded on a plaque. The contents were noted for action at a later date.

2) Members discussed J. Reid's suggestion (letter received 19 June) that Club afternoons for the rest of the season should be devoted to Golf Croquet. The idea was rejected. on several grounds - Golf Croquet already had 2 official sessions to Association's 1; staggered play to utilise the full 3 hours of the Wednesday morning session would lessen waiting time for play on this day; play on Lawn 4 would soon be allowed. The Secretary was asked to reply accordingly.

Reports. 1) M. Stant reported that a Golf Croquet match had been arranged at Budleigh Salterton for 25 June with a team of 8 players. A return match at Sidmouth would be arranged for a date in September. Members were reminded that a Golf Croquet QRE would be taking place on 5 July, and that the closing date for entry would be 1 July. The Secretary reported that no entries had been received from other Clubs in the Federation.

2) The Cashier reported a balance in hand of £82.36, and it was agreed that £50 should go to the Treasurer.

3) E. Golding gave the sub-committee's report on the proposed steps, details of which would be given by him to the Main Committee, together with the quotation of £404 (ex VAT). Members agreed this was a very reasonable figure, and the Chairman thanked the sub-committee for their work.

## REPORT: 1991

As the new committee took office in November of last year, hopes were high for the releveling project just getting under way, at the completion of which Sidmouth would enjoy the status and prestige of being a 4 Lawn Club. You will all know that considerable difficulties conspired to delay the work, and it was not until July of this year that Lawn 4 was marked out for unlimited play. The Tennis Section's co-operation in allowing us use of their lawn tennis area through June was much appreciated; the sterling work by the groundsman Peter Montgomery is already bearing fruit and our thanks are due to him for the particular interest he has taken in this new lawn; and special words of gratitude must go to Bill Kennedy whose protracted involvement in a tangled web of problems deserves recognition, particularly as after November of 1990 he was no longer a committee member.

A condition implicit in our acceptance of financial help from the Croquet Association is that our lawns should from time to time be available to host Open Tournaments. As you will appreciate, Open Tournaments bring revenue to the Club, a certain cachet within the C.A., and an excellent chance for our members to compete with members from other clubs in the comfort of their own surroundings. Your committee has decided that our 1st venture will be a 5-day tournament from 1 - 5 June. Iris Dwerryhouse has volunteered her expertise to be Manager and Secretary for the event, will be giving more details of this later in the meeting.

Membership. You will recall that in the Committee report for 1990 the notional figure of some 25 new members was suggested as a desirable target for 1991. I am glad to tell you that out of 30 people interested enough to take the 6-lesson initial training course, 24 have become playing members. This response to a daunting challenge was only possible through a considerable amount of time, effort and dedication on the part of our team of coaches, and I know you would all wish to recognise and applaud their service to the club. We hope our new members have had an interesting first season. Some have already had success in competitions, and great things are expected from you all in your 2nd year.

Our total membership is at present 110 plus 1 Country member. 4 members became Associate members of the Croquet Association early in the year, and 2 more have recently joined, thus making the number of Associate members within the Club 29. All other members were in March registered automatically as Affiliate members, since as a Club we are registered with the C.A., but we would like to encourage more members to become Associates; and newer members of the club are reminded that Associate membership is a necessary qualification for entering Open Tournaments as individuals.

A number of our members did play in Open Tournaments this year. Our Chairman and the Club President played at Southwick in the Veterans Tournament; and we were well represented at Budleigh in May, August and September. In the August event Tony Dustan-Smith won the Oliver Bowl, the trophy for the Open handicap singles; and also qualified for a Bronze Award, a CA merit award given for a break of 10 hoops or more, using bisques. Congratulations, Tony.

SW Federation. We have had mixed fortunes in the SW Federation matches this year. In the B League only one point on aggregate prevented us from being semi-finalists. In the Intermediate we reached the semi-final when we were beaten in a very close match by , Plymouth. In the Federation League we won only 1 of the 5.

In the Longman Cup we got to Round 3, though I have to confess that we did have a bye in Round 1.

7 members entered for the All-England Handicap and Tony Dustan-Smith went to Bristol as an Area Finalist.

In May we hosted a Federation Short Croquet 2 day Open Tournament and hoped to witness the interesting spectacle of Leslie Toye presenting the Dorothy Toye Cup to himself. He was however beaten into 2nd place by Audrey Whittaker, one of a very competitive contingent from Bath.

On the following day a friendly (no prizes) Club Short Croquet. Tournament was enjoyed by members.

An Egyptian Tournament in June was very popular; and at the end of the season we tried out a new singles competition, played by Advanced Play rules but with normal handicaps - in simple terms a cross between the Belmont and Humphrey Hicks tournaments. It was good fun and an interesting experiment, but in the judgement of the 12 who took part, hardly worth repeating next year.

The yearly Club Tournaments were well supported, with a total of 239 entries for the various events. Matches were not being played off as early in the season as our organizer would have wished, but a last-minute flurry of activity produced the required finalists, and the 2 days of Finals at the end of August were enjoyable. You will be reminded of all the results at the end of the meeting when the prize giving takes place.

Golf Croquet enjoyed its usual popularity as the season got under way and the weather improved. The traditional friendly matches with Budleigh Salterton were held, in July at Budleigh. The Budleigh team were ahead when rain stopped play; in September the return match at Sidmouth produced a draw. A Qualifying Regional Event for the SW Federation was played in July and the Club hosted the Regional Finals in September.

Training. At the end of February a pre-season Croquet Refresher morning was well attended and much appreciated; and Monday afternoons through the season were reserved as Club-afternoons for training in different aspects of the game.

There are a couple of new facilities to report; a seat on Lawn 1 in memory of Fred Moores - our thanks to you, Betty, for your generous gift; and steps from Lawn 4 down to Lawn 2, the cost of which was borne by the Main Club helped by a gift of over £100 from the late Lady Ferrnor.

Finance. The Croquet Section's contribution to the funds of the Main Club continue to be substantial. This year it is expected to top £6000, an increase of 56% over 1989/90. The cost of maintaining the croquet lawns, and buildings comes out of this sum of course, so it is not all profit.

Social Activities. In the winter months help, to maintain our contact with one another, when our monthly Whist Drives provide amusement and companionship as well as some £100 towards funds. Our continuing thanks to those who organise and those who serve tea.

The Annual Lunch was held in March at the Woodlands Hotel, and was fully subscribed. Now that our numbers are so large, we may have to seek out an alternative venue for next year's event, Any suggestions would be welcomed.

Publicity. This being the designated Year of Sport we were asked early in the year to give special attention to publicizing Croquet. This did present some difficulty as we already had a lengthy waiting list and too many interested parties could have been an embarrassment. Our location anyway provides a continual public image. We did on National Croquet Day, 1 June, turn out in immaculate whites, but as the day was particularly inclement, we did not attract the crowds.

in July however a team from TV SW spent 4 hours filming one of their number being coached by David Purdon, the Regional Training Officer, on Lawn 2 and this emerged as a 4 minute slot in a programme on 'Minor Sports'. Our thanks to David for giving his time- in the interest of presenting the right image of the game - it did come over very well. Both Iris Dwerryhouse and John Hatherley had walk-on parts in the final presentation.

There have been a number of problems this year in connection with the creation of the new lawn, notably one of providing practice availability. The Committee has been conscious of the need to have practice slots, particularly for new members, and hopes that the mid-day half-hour was of some use. Double banking proved to be essential requirement in friendly Association games, and it must be said that although it was not wholly popular it was in fact good training because frequently in Federation games and Open Tournaments double banking is the order of day. The Golf Croquet players also had the frustrating restriction early in the season of only 2 lawns for play. This was unfortunately necessary so as not to cause damage by over-use of the lawn tennis area, so generously lent through June. Your Committee does thank you all for your forbearance during a nail-biting time.

We have been compensated for our early problems by having a greatly extended season this year thanks to the interest and enthusiasm of Peter Montgomery, the Club's groundsman. I am sure you would wish to register your appreciation of his excellent work on our behalf.

Last year's report contained the phrase 'a multitude of jobs to be done'. This continues to be true because we are a self-help Club running on the proverbial shoe-string, and willing hands are always needed. There are far too many of you for me to dare to start naming names but your Committee is most grateful for the help given in so many ways through the past year by so many of you. One name that must be mentioned, of course, is that of our retiring Chairman. Your Committees, Iris, over the past 3 years, thank you for 3 years of dedication and selflessness, and patient teaching of those of us who in the world of croquet have been willing but woefully ignorant. We owe you a great deal.

Your Committee hopes that you have all had a good year of croquet, and wishes you all good health and good fortune into 1992.
