

MANUSCRIPT MINUTES OF THE CROQUET CLUB

29 OCTOBER 1966 to 13 JANUARY 1975

Committee meeting held at the Club Pavilion on Monday 13 January 1975

Apologies for absence received from Mr Glover and Mrs Holt.

Mr Fletcher took the chair – also present Mrs Dwerryhouse, Dr M D Rawkins, H Ovens, A Verity.

The minutes of the C'tee meeting held on 4.11.74 were read and approved.

The minutes of the AGM held 21.11.74 were read.

Handicap Committee for 1975 will be Messrs H Ovens, V Stirrup and L Fletcher. Any 2 to form a quorum. CA handicaps to be dealt with by Mr Tunmer.

Secretaryship Dr D Rawkins (proposed by Mrs B Ovens and seconded by Mrs Dwerryhouse) accepted secretaryship. It was proposed that Mrs Togni be asked whether she would act as assistant secretary.

Report of meeting with Club general committee was given by Mr Ovens who attended in place of Mr Fletcher. Meeting held 15.12.74

Matters requested to be raised

Tea charges our letter of August 1974: our letter had been lost but it was felt prices had been overtaken by inflation anyway.

General Committee Meetings have to be held every 3 months in future – at least – to be last Sunday in March, June, Sept, December. Mr Ovens requested that his name be withdrawn as deputy to Mr Fletcher (Club Captain) to attend these meetings.

Parking of Cars by our lawn 1 on public footpath. The chairman promised to look into the matter but Lloyd Baker wants to park there. A difficult situation arises – but the secretary was asked to write to the Club requesting that if a rules was passed prohibiting parking the Croquet Club would adhere to this – in view of a remark that a Club member had parked on this footpath last season.

Cleaning of Ladies toilets etc The discussion concluded in an impasse which was not resolved. Report attached. The matter should be raised again.

It was resolved that Mr Scott as Chairman of Ground committee be final arbiter as to whether lawns are fit for play or not. An Officer on all croquet matters to liaise with Mr Scott was asked for -Mr Fletcher (proposed by Dr Rawkins, seconded by H Ovens) appointed. The Club and Croquet Members would be advised of this.

A list of Officers and Committee of the Croquet Section would be placed on the Club board.

Thanks were passed to Mr Ovens for his attending the Club General Committee.

“Opening Luncheon” Mrs Dwerryhouse had obtained details from Gables Hotel and Belmont Hotel. The former could not book Wednesdays and as the season had commenced, the latter could not provide a separate dining space for us. It was resolved to ask Mrs Dwerryhouse to obtain details from the Riviera Hotel- and to arrange a date (April 8, 9 or 10) with that hotel. Or with the green Gables. – as we would require to have sole occupation of a room for lunch & meeting.

Arrangements for 1975 it was resolved to hold a “Novices Doubles”.

Other tournaments and matters with CA to be discussed at the next Committee Meeting.

Messrs Ovens, Fletcher Verity Stirrup would assist in Golf Croquet sessions.

It was proposed by Mr Fletcher and seconded by Mrs Dwerryhouse that Messrs Verity and Stirrup be co-opted as Committee members for the year.

Equipment for 1975 it was resolved to ask the Club to purchase two sets of balls and a set of corner flags for the coming season.

The next committee meeting would be held on Monday 10 February at 11am

General Meeting of Members held at the Club Pavilion on Thursday 21.11.74 at 10.45

Mr Glover in the Chair and 43 members present

Apologies received from: Mr R Michelmore, Mr & Mrs Reid, Mrs A Mosser.

The minutes of the General Meeting held 25.10.73 read and approved.

The secretary read correspondence from the CA and asked for names of any members who would be interested in attending the Clubs conference at Hurlingham on 7 December. Also re a proposed match with a CA team next season. It was decided to accept the latter – perhaps with a team of four – CA to be advised. A drive is to be made for croquet association membership.

The report of the 1974 season was read and approved.

Arrangements proposed for the 1975 season

Singles = handicap – to be knock-out as in 1974 either an X/ Y or Draw & Process as C'tee decide.

Doubles knock-out as 1974 probably X but X.Y if numbers warrant.

Would the C'tee go into possibility of arranging a Doubles with the high bisquers only playing but instructed by the senior – playing a short course.

Golf Croquet afternoons as last season – fortnightly when no all-day cricket – then 2 during the latter period. Also considered to be given a morning start 11.30 with picnic lunch for a Golf Croquet session. Volunteers requested to help with these sessions and so 'spread the load'.

Ladder Discussed – a majority of members passed the suggestion that all names be entered on Ladder and those that do not wish to play should withdraw and not hold-up progress of tournament.

What action to be taken when a member is away for a 2 or 3 week holiday?

The committee to explore the possibility of a Croquet Gymkhana afternoon for all members.

Mr Fletcher was invited to arrange a further 'Refresher Course' in 1975.

A Finals Day for Club competitions to be arranged.

The Committee to arrange a luncheon date for members to open the new season.

Mr Fletcher reported on the percentages of Court usage and suggested new booking times which were agreed by the members. These are: 10.30 – 1, 2 – 4.30, 4.30 – Double banking on Court 1 at 4.30 in No 2 also booked. The session 1-2 is available for practice.

The List of Handicaps for 1975 season was exhibited.

Officers for 1975: Chairman Mr Glover, Captain Mr Fletcher, Committee: Mr Ovens, Mrs Holt, Mrs Dwerryhouse, Dr Rawkins (proposed by Mrs Ovens seconded by Mr Stirrup)

Mr Tunmer wished to resign as secretary but would be prepared to remain on committee. No nominations for secretary were received. Committee would deal with this at the next Committee meeting.

The awards for 1974 season were presented by H O Hicks.

The meeting closed at 12.05 with a vote of thanks to the Chairman.

A social hour was then enjoyed by all present.

Minutes of Committee Meeting held at the Pavilion on Monday 4 November 1974

All committee members present. Mr Glover in the Chair.

The minutes of the Committee meeting held 21.8.74 read and approved

Matters arising Mr Ironside and Mr Skinner had confirmed it would be in order for the croquet section to depute a C'tee member to attend the General C'tee in the place of the Captain if was unable to be present.

Finance Mr Tunmer informed the c'tee that he held an amount £4.05 being £2.35 received from Mr Fletcher as balance of Training Courses and £1.80 in competition fees collected. The c'tee confirmed a payment of £1 to the secretary as out of pocket expenses leaving a balance of £3.05 carried forward.

Cups to be presented at the AGM and to be presented by Mrs Michelmore.

Singles Competition Belmont Challenge Cup – Mrs E G Tunmer

Doubles Competition V Stirrup & Mrs Rawkins

Longworth Cup – for the most improved High Bisquer Dr D Rawkins

The Croquet Club Cup – for endeavour and service to the Club – H Ovens

Arrangements for the AGM were discussed. Mrs Holt & Mrs Dwerryhouse would attend to light snacks etc. (AGM on 21.11.74) Mrs Michelmore would be asked to present the Cups

Miss Ironside would be invited to attend.

1975 season. Competitions to be held:

Handicap Singles on X / Y basis

Handicap Doubles – type to be decided on by members at the AGM either 1. High Bisquer 16+ drawn with senior partners – only high bisquer plays – shortened course shortened game. Knock-out competition possibly X Y depending on number of entrants.

Or 2. Partners drawn by C'tee – high bisquer with low bisquer both partners to play. 3 hour game 22 point points.

The members would be asked whether they would wish the Ladder competition to run as before – the right to challenge 3 above or 1 across – all players on their second year automatically entered with the rest. OR put up a list for entrants to put their name down. It had been felt that some players automatically entered had not played games on the ladder during the season.

Members would be asked if a Refresher Course would be required in 1975 – Golf Croquet would be played as usual. Also to whether a one day match with a CA side could go forward – invitation had been received from CA. The following resolution proposed by Mr Glover and seconded by Mr Fletcher for booking times in 1975.

10.30 – 1 2 – 4.30 4.30 - The record of bookings maintained by Mr Fletcher that 3 pm had shown the fullest court use with 10.30 second. The hour from 1 to 2 could be used for practice (not booked). Double-banking allowed for the 4.30 session.

Officers for 1975. Mr Tunmer asks to be relieved of the secretaryships as he was now living away from Sidmouth. He would be prepared to continue as a committee member. The other officers were prepared to accept office 1975. The AGM would be asked if there were any other nominations.

The C'tee suggested that a notice should be placed on the members' board before the 1975 AGM inviting nominations for the c'tee (duly seconded and having established that the nominee is willing to serve.) There is no limit to the number of Committee at present. Perhaps this might be discussed in due course.

AOB Dr Rawkins wished the committee to explore the possibility of a FINALS DAY for the singles & Doubles competition in 1975. This would be discussed when finalising 1975 arrangements – early September was a possible time.

Mrs Dwerryhouse asked that representation be made to the General Committee about the regular cleaning of the Ladies toilets and Changing Room – so often in a very very dirty condition – as it was understood that this should be part of the duty of someone being paid for this work.

The next committee meeting fixed for 13 January 1975

Committee Meeting held at Lloyds Bank Flat Sidmouth on Tuesday 27 August

Present Mr M H Glover (Chairman), Mrs Holt, Mrs Dwerryhouse, Mr Ovens, Mr Fletcher, Mr Tunmer.

The minutes of the Meeting held on 15.7.74 were read and approved.

There was some discussion as to who would bear the cost of the 2 signs for the Pavilion's doors. It was decided to have the account sent direct to the Club as the labour on the work was being done by Mr Ovens.

Correspondence received was read by the secretary – one letter to the Club re 3 notices to be put-up as suggested by our committee was read – Miss Ironside had replied giving permission for the notices on the croquet door and the Ladies toilet could be proceeded with – but that the one suggested for the outside men's toilet should be labelled as such not "Visitors" which might lead to some confusion and embarrassment. The matter of catering charges would be brought before the next General Committee.

The Chairman would ask Miss Ironside whether a deputy from the Croquet C'ttee could attend ant General Committee Meeting if Mr Fletcher would not be able to be present. Mr Ovens would be prepared to do this. The secretary would speak to Mr Scott re the cutting of lawns and also the propose rubber underlay on the posts of the wire around lawn 1. Cutting should be done to allow games to begin at 10.30. If a 3 hour tournament game was to be played the competitors should inform the groundsman that they wished to commence at 10.

It was agreed that Visitors paying a green fee should only play on Lawn 3 – unless they are bona fide members of other CA clubs

It was agreed to appoint a Club Handicap Committee Messrs Tunmer, Ovens and Fletcher. They should meet regularly and have power to alter CLUB handicaps during the season. In order to increase differential of our members it was agreed that 20 should be the highest handicap in the Club

Next season from 18 as at present.

It was agreed to ask our representative on the ground committee to request them that:

1. A regular monthly C'ttee meeting should be called instead of the infrequent meetings arranged with very short notice – decision an urgent matter now much delayed.
2. To seek some solution to the parking of cars around the Pavilion and alongside the croquet lawn. Should not the gate at the entrance be kept locked?

The AGM would be arranged on Thursday 21 November at 10.45 am at the Club Pavilion – to be followed by a social session with bar and snacks. Mrs Michelmore would be asked to present prizes.

The possibility of a luncheon to open the 1975 season would be discussed at the AGM.

The next committee meeting arranged for Monday 4 Nov.

The chairman thanked Mr & Mrs Holt for their kindness and hospitality in enabling the meeting to be held at their home.

The meeting concluded at 12.30

Committee Meeting held at the Pavilion on 15.7.74

Present Mr M H Glover (Chairman), Mrs Dwerryhouse, Mrs Holt, Mr Fletcher Mr Ovens, Mr Tunmer.

The minutes of the Meeting held on 28.5.74 were read and approved.

Matters arising Singles Competition

Confirmation given to the amendment made, before the competition started, for the games to be played for 2½ hours commencing at Hoop 3.

Golf Croquet Owing to the falling off of entries for the last 2 afternoons it was decided to put up a notice that 22 entries would be the minimum for the playing and the matter of the number of Golf Croquet sessions to be held should be discussed at the AGM.

Training Course

Mr Fletcher reported on his successful refresher course held on July 10 & 12th. Attendance was 19 on the first day and 15 on the second day. He had arranged for the use of the CA film strip and commentary which was most useful. His efforts were most appreciated by all who attended and the c'ttee expressed their thanks for all that he was doing in the Training Sphere. Thanks also to the CA for their help sec. suggested we should attain more CA association members for our Club.

Reimbursement from the Club would be sought for the 2 sets of hoops purchased by Mr Fletcher at £2.

Membership figures were reviewed again and Mr Fletcher's analysis chart of lawn usage was proving most useful. The secretary was requested to contact the Club Secretary with regard to Visitors [non-members] play. No advance booking to be allowed but they could be allotted lawns 2 or 3 if available for a session at the agreed fee – the groundsman to point out the mallets and balls available. Visitors could only play on Lawn 1 with a member and must pay the fee before playing.

Line marking again commented upon and sec again asked to draw attention to this at the ground c'ttee and request that all lawns be mown especially on Friday, prior to heavy weekend bookings.

The letter re the Catering Tea charge for the members was read and it was agreed to forward this to the Club Sec. for the attention of the General Committee (prop. Mr Ovens, sec Mr Fletcher).

"Croquet" members premises Discussed but agreed that no structural work could be suggested – but ears kept to the ground with the possible alterations to be required by the Fire Authority in the near future. The present notices could be enlarged by the members if agreed by the Club. Croquet Door to read "TENNIS and CROQUET CLUB MEMBERS ONLY". The outside toilet to be the visitors' toilet. The notice on the locker room in the tea room to be more prominent. This all implements the desire to exclude the public from the changing rooms. The Croquet Club would pay for this work. The Club's approval to be sought as soon as possible.

New wire surround discussed the ground staff's enthusiasm commended but it was felt that the system was not 100% good. The steel supports could be cushioned with rubber underlay to prevent damage to the balls.

Correspondence from CA was read re plans they would like to make for 1975 season re the development scheme. It was felt that our Club service most of the courses offered and the difficulty of obtaining sole use of the Clubhouse at weekends during the season would not be possible. A letter would be devised by Messrs Fletcher & Tunmer in reply. The offer of a CA team to visit for a day match in 1975 would be put to the members at the AGM.

The next C'ttee meeting arranged for 27 August at Mrs Holt's home. The meeting concluded at 12.30.

The Chairman would approach the Club Sec re three matters raised at this meeting including levy advice re cricket meeting to Mr Fletcher.

Committee Meeting held in the Club Pavilion 28.5.74

Present Mr M H Glover (Chairman), Mrs Holt, Mrs Dwerryhouse, Mr Fletcher Mr Ovens, Mr Tunmer.

The minutes of the Meeting held on 18.3.74 were read and approved.

Matters arising: None

Correspondence rec'd letters from Mrs N Moore (resignation owing to leaving the district) and Mr Case, a new member this year who will be joining the Club in mid-June.

The season competitions Decided to play singles & doubles on X / y basis. Draw was made for block competition 'X' round. Singles full course 3 hours time limit. Doubles full course 3 hours time limit. Entries were 19 for singles and 18 (9 couples) for doubles.

Golf Croquet dates arranged for the season. Appreciation expressed where we run our own tea and biscuits for the instance when no 'cricket tea' is available.

Training Course Mrs Fletcher will call together the members who have expressed a wish to join this course a arrange for as commencement date. He is still running successful Monday morning sessions for beginners.

Test Match England v New Zealand preliminary plans given – full publicity to all members when this is received. The Budleigh Club have asked if we could assist with transferring the New Zealand team members to and fro from the Devonia Hotel Sidmouth where they are staying. Several c'ttee members expressed their willingness to to join in this and we await further arrangement details from Budleigh. A list for volunteers will be displayed in the Pavilion here.

Our membership list now numbers 50 paid-up members. It was discussed if we should "close" the membership – but it was felt we would not recommend this at the moment. All the bookings of lawns was very heavy – Mr Fletcher was keeping details of this.

AOB Line markings have been poor – we would ask for those to be improved. *We have again written to Jacques re 2 new winning pegs.*

Mr Fletcher had been offered 2 sets of hoops at £1 each Recommended that the purchase be made.

Mr Ovens moved on behalf of several members, that a letter be sent to the Club complaining about the tea time prices now charged to members of the Club – and suggested we had now reached a position of diminishing returns as many croquet members will bring their own 'thermos'. This was agreed – it was felt that the cricket teas were being subsidised and that whilst the high prices no being charged should be levied on strangers that Club Members, many of whom help in the kitchen work, were being overcharged.

It was left to Messrs. Ovens & Tunmer to draw-up a suitable letter to be sent to the Club.

There being no more business the meeting closed at 12.30.

The next meeting fixed for Tuesday 27 August at the Club.

Committee Meeting held on 18 March 74

Present Mr M H Glover (Chairman), Mrs Dwerryhouse, Mr Ovens, Mr Tunmer. L Fletcher
Mrs Holt still abroad will be home on 2 April.

Minutes of the Meeting held on 11.2.74 were read and approved.

Matters arising. Mr Ovens proposed and Mr Fletcher seconded an amendment to the booking times for lawns now to read: 1 – 3 and 3 – 5.30 Agreed.

Mr Fletcher displayed a plan for booking which was approved – he will have 100 of these printed.

Luncheon 28 March 29 acceptances to date. The menu was discussed and Mrs Dwerryhouse would inform the hotel that the suggested menu as rendered by them would be acceptable.

The “Apps Heley” plaque would be displayed to members and thereafter would be set-up in the Club bar.

After lunch the arrangements for the coming season would be stated & entries for Tournaments accepted (an entry fee to the Club events – singles 10p – doubles 5p – would be levied)

Mr Fletcher would organise an advance training course – details considered and approved - 4 sessions in all.

It was hoped to begin play at Easter.

The Ladder Mr Ovens proposed that this competition finishes on 30 September Agreed.

Golf Croquet dates would be made as soon as possible – organisation of these afternoons to be shared by four or so members to help spread the work.

The meeting concluded at 12.05

No date arranged for next meeting.

Committee meeting held at the Club Pavilion – Monday 11 February 74 at 11am

Present Mr M H Glover (Chairman), Mrs Dwerryhouse, Mr Ovens, Mr Tunmer. L Fletcher

Apologies for absence received from: Mrs Holt

The minutes of the Meeting held on 18.10.73 were read and adopted. Mr Ovens welcomed to the Committee. The minutes of the general Meeting held on 25.10.73 were read.

Matters arising: Club Handicaps Proposed by Mr Ovens seconded by L Fletcher that all Club Handicaps as at the end of 1973 should be increased by 2 – to conform with CA intention – and that 18 be the highest handicap given by the Club rather than 16. Agreed

Double Banking with alternative colours

It was agreed to make booking periods for the lawns:

10.30 to 1 1 to 3.30 3.30 to 5.30 5.30 to 7.30 increase of 1 session per day.

Alternative Colour Double-Banking on all lawns 5.30 to 7.30 only

We should ascertain member reaction to these proposals during the season and amend if wished.

Secretary's Report & Correspondence

Letter received re the coming Test Match Series 1974 – One official programme ordered.

The Apps Heley Award (£10 cheque) was accepted by the secretary at Hurlingham's Clb Conference on 8.12.73. It was resolved that £3 travelling expenses be taken by the secretary – and the £7 balance be used for a 'plaque' to be made (7" x 3"?) to be put in the Club referring to the award. The secretary would obtain an estimate for the work involved and report back.

Equipment The Club be requested by the secretary to purchase one set of alternative coloured balls and one or two new pegs to complete a set of 3 for the lawns. We have 3 sets of playable colours and 1 set of alternatives colours & 2 new sets of first colours in stock. Mrs Dwerryhouse had in stock sufficient material for any further sets of corner flags. Mr Fletcher said he would make a new set of corner flags if required.

Captain's Report Mr Fletcher had attended 2 Club Committee meetings and his reports on these were read and appreciation expressed for his work in the matter.

Points for Minutes 1. The Club would place "Cycling Prohibited" notices at each end of the path through the ground.

2. The small gate from the Terrace to the Tennis Courts and 2 And 3 croquet lawns would be kept unlocked this season.

3. The No 3 lawn would be laid out, mown and rolled, in the space adjoining No 2 lawn – full size. It would show inaccuracies and work next Winter could be done to improve the condition of the new lawn.

Plans for 1974 Club Tournaments

Singles T'ment A knock-out on 2 life or x / y system 2½ hours limit.

Doubles T'ment High Bisquers partnered by low bisquers – knock-out also 2 life or x / y system 3 hours time limit.

Lists for entries to be withdrawn for draw on 25 May

Ladder All "second year" members together with all members to go on Ladder – and will be placed in order as drawn at the beginning of season. New members can automatically be placed on ladder. Rules as last season.

Golf Croquet A new “course” for play – to avoid delay around hoops had been suggested by Vincent Stirrup and it was decided to try this out. There would be 2 separate courses i.e. hoops 1, 2, 6 and 3, 4, 5. 25 Minute games – hoops / points score.

It was suggested that the Golf Croquet Tournament be held fortnightly on a regular day (Tuesday or Wednesday) from as early as possible in the season.

Training Courses It appeared that there would be no call for a full course in 1974. Mr Fletcher would be pleased to organise a “Revision Course” of 4 sessions for all who would be interested. The basis of this course would be from Lesson 3 onwards.

The Committee expressed their thanks to Mr Fletcher for all his fine work as an official coach.

C.A. Tournaments It was agreed to seek entrants for the “All England” competition – minimum of 4 required.

Entry for the ‘Longman Cup’ was discussed but difficulty of travelling etc caused “no action” to be decided.

Club Luncheon Messrs Ovens, Tunmer would contact 2 hotels re arranging this for Thursday 28 March and action would be left to them. The function would also give a chance to present the season’s plans to the members.

The next Committee Meeting was arranged at the Club on Monday 18 March at 11am.

General Meeting of Members held at the Club Pavilion on Thursday October 25th at 11am

Mr Glover in the Chair – 35 members present

Apologies received from: Miss Becker, Miss Catlin, H O Hicks, Capt & Mrs Vincent, J Hagger, Mrs M Sherwin and Mrs Dwerryhouse.

The minutes of the general meeting held on 19.10.72 were read and approved.

The Committee's report for 1973 was read and approved.

Arrangements for season 1974 were discussed.

Lawns: The Committee were asked to stress the need for a full-sized third lawn. The secretary assured the meeting that the Club would do all it could to improve the playing conditions of all the lawns etc. A new scarifier had been purchased and there would be 2 groundsmen appointed.

Mr Ovens asked whether any action had been taken re the children cycling on the footpaths etc and generally making a disturbance in and around the Pavilion and Croquet Lawn. The secretary read a letter sent to the Club on the matter suggesting that notices "Cycling strongly prohibited" be erected. Action had been taken by them and the cycling and things had improved, but we understand that the Club was against more notices on the ground. The meeting felt, however, that notices should be erected and so gave members authority to stop offenders by drawing their attention to them. The secretary would again press this with the Club.

Meeting closed at 6 o'clock

7th October 1968

An end of season tea-party was held at 4.30 pm at the Cricket Pavilion which was attended by 13 members and enjoyed by all.

After tea a meeting of members was held and apologies were received from Mrs Michelmore & Mr H. O. Hicks. All present were sorry to hear of Dr Michelmore's illness and asked the secretary to write to Mrs Michelmore conveying their sympathy and hoping for his speedy recovery.

The secretary reported that Mr Shelton had won the American Singles Tournament and there was great competition for second place and eventually Mrs Michelmore and Mr Hodgson tied for this honour. The doubles were won by Mrs Michelmore and Mr Waterfield. The spoons were given by Mrs Corbett for which she was adequately thanked. The Hon. Sec. presented Mr Waterfield with the doubles prize and the secretary was asked to see that Mr Shelton received his spoon as soon as possible.

The secretary reported that he was retiring from that post at the end of the year and Mr Tunmer had promised to take over and carry on this work, he was duly elected unanimously.

Mr Glover was asked if he would stay on the committee to help out, this he promised to do. No other members were elected owing to the absence of Mr Shelton who is a Committee Member & this should be done at a later date.

Coaching One person at a time say ½ hour to each person only if others are waiting. Those wishing to be coached to get in touch with and arrange time with coaches. Suggested that those with handicaps of 10 & under should be coached by Mrs Michelmore & Mr Fletcher. Those above 10 to be coached by Mrs Corbett, Hodgson, Tunmer etc.

Tea Party possibly to be held in early May, quite informal, long table if possible.

Mrs Shelton Size of Court to keep in touch with Harris.

Key of Clubroom A place to be arranged for the keys to be found so that players coming to play after the Pavilion & Hut are closed can find them.

Notes of Croquet Club Meeting Held in the Bridge Room of the Sidmouth Club at 11.30am 14th February 1967

Present Mrs Shelton, Mrs Michelmore, Mrs Corbett, Mrs Dwerryhouse, Mr Tunmer, Rev. ?. Hobson, Mr Hodgson, Mrs C Russell (Sec. Sid. Cricket, Lawn Tennis & Croquet Club) and Mr Glover Hon. Sec Croquet Club.

Centenary Handicap Singles The Secretary reported that he had received notices from Mrs Capon the details of this tournament. In these notices it was agreed that with 4 competitor from the Club we could play the 1st round at Sidmouth and the winner would receive a Bronze Medal and should entrants require a Certificate they were entitled to have one.

Number of entries in this competition to be sent to Budleigh by end of April (Budleigh being our Area Club). The entrance fee to be paid was 3/6. As to the presentation of the Bronze Medal it was agreed by all that Dr Michelmore should be approached by the Hon. Secretary to ask him to perform this for us.

It was reported that the Croquet Club had grown from 11 members to 28 unfortunately 2 had left the neighbourhood.

Reported that the sub-committee had put the highest handicap to 24.

It was reported that due to a slight disagreement amongst the competitors that the prizes were held over.

It was suggested by Mrs R G Michelmore that all American Tournaments should finish at the end of 3 hours and supported by all members present.

It was suggested that the small lawn should be made bigger and it was left to Mr Shelton to see Harris the groundsman.

Centenary Year Mr Shelton was congratulated on winning the bronze medal played for at Sidmouth and the silver medal at the area finals played for at Budleigh Salterton and went on to reach the semi-finals in London.
